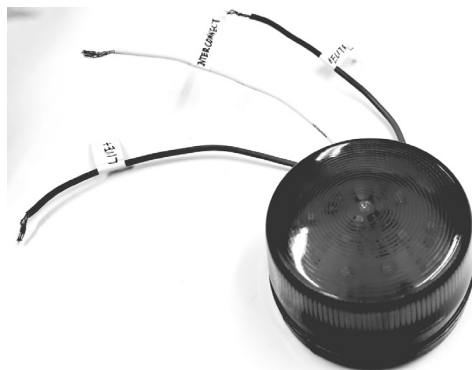
#### PRODUCT DESCRIPTION

The HSSA/STROBE is a mains powered Flashing Strobe. This Strobe connects into the Alarm system via a relay base or module.

If the alarms trigger the relay will send out a signal that triggers the Strobe to flash. The Strobe is an alarm accessory that is designed to give a visual warning if a properties alarm system has been triggered.

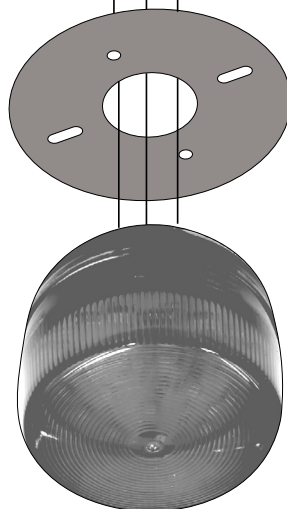
#### INSTALLATION

1. Connect the AC wires from the strobe light unit to the wires from ceiling.



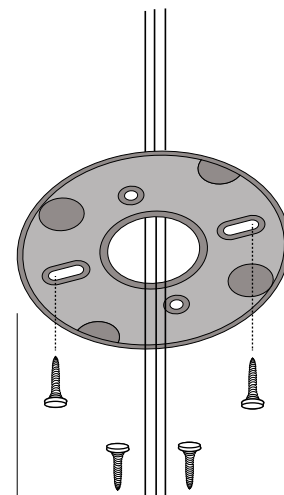

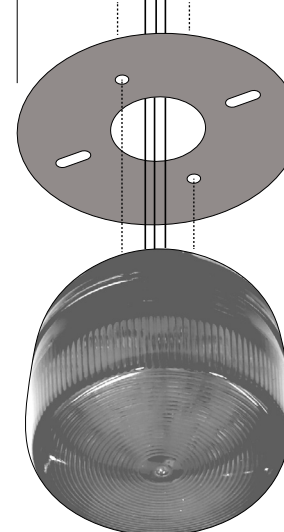


2. Screws the Mounting Bracket as below diagram.
